A. ATTENDANCE AND ORGANIZATION OF WORK

Place and date of the meeting

1. The Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean held their sixty-first meeting virtually from 29–30 September 2021.

Attendance¹

2. The meeting was attended by representatives of the following member countries in their capacity as Presiding Officers: Antigua and Barbuda, Argentina, Brazil, Chile, Costa Rica, Cuba, Dominican Republic, Ecuador, El Salvador, Grenada, Haiti, Jamaica, Mexico, Nicaragua, Panama, Paraguay, Peru, Plurinational State of Bolivia, Saint Vincent and the Grenadines, Suriname and Uruguay.

3. Also attending were representatives of the following member countries of the Economic Commission for Latin America and the Caribbean (ECLAC): Bahamas, Barbados, Belize, Bolivarian Republic of Venezuela, Colombia, Dominica, Guatemala, Guyana, Honduras, Italy, Norway, Saint Kitts and Nevis, Saint Lucia, Spain and Trinidad and Tobago.

C. SUMMARY OF PROCEEDINGS

12. At the opening session, statements were made by Raul García-Buchaca, Deputy Executive Secretary for Management and Programme Analysis of the Economic Commission for Latin America and the Caribbean (ECLAC), representing Alicia Bárcena, Executive Secretary of ECLAC; María-Noel Vaeza, Regional Director for the Americas and the Caribbean of the United Nations Entity for Gender Equality and the Empowerment of Women (UN-Women) and Mónica Zalaquett, Minister of Women’s Affairs and Gender Equity of Chile, in her capacity as Chair of the Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean.

13. After welcoming the participants, the Deputy Executive Secretary for Management and Programme Analysis of ECLAC said that the crisis caused by the coronavirus disease (COVID-19) pandemic had hit the region hard, exacerbating gender inequalities, and that the ongoing recovery was very uneven. He highlighted the plan for self-sufficiency in health matters proposed by the Community of Latin American and Caribbean States (CELAC), with the support of ECLAC, which consisted of seven lines of action aimed at strengthening the health manufacturing industry as a dynamic sector for achieving recovery with equality. Recalling that the pandemic was not yet over, he stressed the importance of pushing for expansionary fiscal policies and a new fiscal compact, of strengthening regional cooperation to secure the necessary resources and of ensuring an enabling macroeconomic environment for gender equality. He emphasized the importance of investing in the care economy in order to make it a strategic and energizing sector with the potential to contribute to a transformative recovery, with gender equality and sustainability at its core. He concluded by referring to the work that lay ahead until the next Regional Conference on Women in Latin America and the Caribbean, to be held in 2022, to advance the transformative recovery.

14. Next, the Regional Director for the Americas and the Caribbean of UN-Women said that the meeting of the Presiding Officers coincided with the seventy-sixth session of the General Assembly of the United Nations, the appointment of the new Executive Director of UN-Women and the adoption of UN-Women’s 2022–2025 Strategic Plan. She underscored the urgency of ensuring women’s participation in all cooperation plans and processes to find comprehensive solutions for recovery from the pandemic. She highlighted the joint work of the governments, UN-Women and ECLAC with women’s organizations in the framework of the Regional Fund in support of Women’s and Feminist Organizations and Movements, and the importance of providing these organizations with sufficient resources to strengthen and operate in the context of the crisis caused by the pandemic. She recalled that UN-Women and ECLAC had insisted on the need to develop public policies that addressed the care crisis caused by COVID-19. Finally, she encouraged the authorities to continue working for the well-being, empowerment and autonomy of women and girls and to build fairer and more egalitarian societies.

15. Lastly, the Minister of Women’s Affairs and Gender Equity of Chile, in her capacity as Chair of the Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean, warned of the fragility of the achievements in gender equality, which called for increasing the strength and momentum of actions to protect them. The international community had been called upon recently to

redouble efforts to ensure the human rights of women in Afghanistan. She recognized the leadership shown by various countries in the region in the Action Coalition, in the framework of the Generation Equality Forum: Mexico, as co-host of the Forum and with the Global Alliance for Care; Argentina, for its fostering of sexual and reproductive rights; Costa Rica, with its Gender and Climate Change Action Plan; Uruguay, for the encouragement of cultural changes for a life free of gender violence; and Chile, with the Regional Alliance for Women's Digitalization.

16. She insisted on the need to promote care systems to ensure the sustainability of life and to guarantee public resources to promote co-responsibility between States, the market, communities and households. In that regard, she applauded the federal map of care services that Argentina had launched with the support of ECLAC, as well as the district-based care system implemented by the city of Bogotá. She also said that the pandemic had accelerated the urgency of promoting an inclusive digital transformation that would put women at the centre, as well as effective connectivity, through initiatives such as the digital basket of goods proposed by ECLAC. She highlighted the efforts of the Dominican Republic to promote universal access to digital services with a gender perspective, as well as those of Argentina, which had launched the Centre for Gender in Technology, and Chile, which had promoted the new National Policy on Gender Equality in Science, Technology, Knowledge and Innovation. Lastly, she acknowledged the ability of countries to overcome difficulties and learn from the lessons of the pandemic to build a sustainable future with resilience, as called for in the Santiago Commitment.

Adoption of the agenda (agenda item 1)

17. The Chair of the Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean submitted the provisional agenda for consideration by the Presiding Officers, who adopted it without amendment.

High-level panel: Towards a care society for recovery with gender equality and sustainability (agenda item 2)

18. The panel was moderated by Mónica Zalaquett, Minister of Women's Affairs and Gender Equity of Chile, in her capacity as Chair of the Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean, and the participants included Ana Güezmes García, Chief of the Division for Gender Affairs of ECLAC; Nadine Gasman, President of the National Women's Institute (INMUJERES) of Mexico; James Heintz, Chair of the Department of Economics, College of Social and Behavioral Sciences, University of Massachusetts Amherst, and Board member of the International Association for Feminist Economics (IAFFE); Olivia Grange, Minister of Culture, Gender, Entertainment and Sport of Jamaica; Maritza Velásquez, General Coordinator of Asociación de Trabajadoras del Hogar a Domicilio y de Maquila (ATRAHDOM) of Guatemala and María-Noel Vaeza, Regional Director for the Americas and the Caribbean of the United Nations Entity for Gender Equality and the Empowerment of Women (UN-Women).

19. The Chief of the Division for Gender Affairs of ECLAC argued that the paradox of recovery lay in the fact that women worked in the sectors most affected by the pandemic and where recovery was slowest. While men were already at pre-pandemic levels of labour participation, women still lagged behind by at least 13 years. She then outlined some proposals to achieve a transformative recovery with gender equality and sustainability; for example, investing in the care economy as a dynamic sector, ensuring an inclusive digital transformation and fostering a new fiscal compact with gender equality. She called for accelerating the push for economic, climate and gender justice and advancing the development of a care society that prioritized the sustainability of life and the planet, guaranteed the rights of caregivers and those in need of care, and made visible the multiplier effects of the care economy in terms of well-being. She said that the crisis was a unique opportunity to encourage a new development pattern with equality and sustainability, and the equitable redistribution of power, resources and time between women and men.

20. The President of INMUJERES of Mexico said that her country's national care system should recognize care as a right and a public good, and represented a smart fiscal measure. She stressed that the provision of care would lead to significant economic growth and fiscal returns, as well as foster security, environmental sustainability and peace. She thanked ECLAC and UN-Women for their support in quantifying the investment required for the national care system and noted that an increase in investment of 1.16% of GDP was needed to establish a universal, free, quality childcare system, which would have a number of multiplier effects. She mentioned the importance of joining the Global Alliance for Care, which was an urgent call to action to put the issue of care at the centre, with an emphasis on co-responsibility, and finally, she referred to the first International statement about the importance of care in the human rights arena, presented by Argentina and Mexico at the forty-eighth session of the Human Rights Council.

21. The Chair of the Department of Economics at the College of Social and Behavioral Sciences, University of Massachusetts Amherst, and Board member of IAFFE said that the pandemic had demonstrated how the interaction between market economies and non-market processes could simultaneously trigger a global economic crisis and a crisis in the social organization of care. The interdependence between the market economy and non-market processes required rethinking the limits of macroeconomic policies and crisis management, as attempting to address a crisis by considering the two spheres separately was ineffective. By way of example, he said that energizing the market economy through expansionary fiscal policy, liquidity injections to save financial markets or corporate bailouts was of little use in averting impending climate change or meeting the growing demand for care. He therefore argued that it was necessary to create an economic framework that recognized the unpaid activities that sustained economies and that shifted the focus from production to provision, directing investment towards people and sustainable practices.

22. The Minister of Culture, Gender, Entertainment and Sport of Jamaica underscored the importance of capacity-building through strategic investments to ensure that citizens could contribute to the recovery and transformation of the economy. She mentioned some measures that had been implemented in her country, such as cash transfers to severely affected sectors, special programmes for informal employment, an increased budget for gender-sensitive programmes and the distribution of health-product packages to support vulnerable families. She stressed the importance of measures to reward and redistribute care work, along with government subsidies for workers affected by school closures. Lastly, she noted that gender mainstreaming in the disaster risk management framework had been strengthened in the context of the pandemic.

23. The General Coordinator of ATRAHDOM of Guatemala addressed the issue of self-care for domestic workers and stressed that that should be part of the work agenda in occupational health. Women employed in sectors related to care and services were used to caring for others but not themselves, which had a serious impact on their health. That problem should be addressed from the point of view of prevention, as the responsibility of the employer, but also of governments, which should formulate public care policies. Moreover, domestic workers had been among those most affected by the pandemic, as they had sometimes been confined to their place of work and their working hours had been extended to care for children and employers while they were studying and working from home. Finally, she drew attention to the issue of care for girls who were victims of gender-based violence and to the domestic violence generated and intensified during the pandemic. She referred to situations of labour abuse, such as girls sent to work at an early age and those subjected to labour trafficking, and emphasized the situation of indigenous women.

24. The Regional Director for the Americas and the Caribbean of UN-Women underscored the importance of investing in care, which generated gains on three fronts: decent job creation, training, and career opportunities to enable caregivers to move out of informality and broaden their horizons. Given that it was mainly women who had lost their jobs because of the pandemic, and that the recovery of employment was slow and uneven, investment in care was very important, as it generated direct quality jobs, facilitated

women's participation in the labour market and enabled them to break out of the cycle of poverty. In that regard, she referred to the Global Alliance for Care, a multisectoral initiative aimed at discussing how to develop comprehensive care systems. Lastly, she announced the imminent publication of a document prepared jointly with ECLAC on comprehensive care systems and referred to the study that had been carried out to analyse the costs, returns and effects of a universal, free, quality childcare system in Mexico.

25. In the ensuing discussion, the Minister of Social Development of Panama said that her country had begun to develop an inter-agency, multisectoral and multi-stakeholder coordination mechanism to design a national care system. She also mentioned the implementation of a pilot project to implement care services in the territory with the support of UN-Women. Progress had also been made in developing the national strategy for female entrepreneurship, the national strategy for the integration of girls and young women into STEM disciplines and jobs, the public policy for employability and labour market participation of socioeconomically vulnerable young women and women and in the promotion of the digital basket in Panama.

26. The Minister on the Status of Women and Executive President of the National Institute for Women (INAMU) of Costa Rica said that her country had launched the National Care Policy 2021–2031, which strengthened the national care system with a public-private and co-responsibility approach. She also highlighted the ongoing process to account for investment and the loss in terms of GDP deriving from the failure to invest in care. She concluded by announcing that Costa Rica had joined the Global Alliance for Care.

27. The Minister of Equality of Spain underscored the importance of building strategic feminist partnerships around the care agenda, referring to global care chains, which had allowed the incorporation of women from the global North into public life on the basis of the outsourcing of care work under precarious conditions, mainly by women from the global South, a process that had historically been based on discrimination and exploitation. In Spain, work was being done on several fronts in relation to the care of children and dependent older persons, and the aim was for the State to take co-responsibility for care, to consider it a right and to guarantee the rights of caregivers.

28. The Secretary General of the Federation of Cuban Women stressed the importance of universal social policies and specific policies such as care for dependent persons. According to the National Survey on Gender Equality, the main gaps in achieving gender equality continued to be in the areas of care and domestic work. She highlighted the work of the Cuban Care Studies Network, made up of more than 13 universities, representatives of civil society and some of the country's ministries. She mentioned the support provided by ECLAC in the systematization of good practices in early childhood care, the government's approval of the opening of day-care centres for young children and the continuation of efforts to build local capacities and provide local actors with the knowledge and skills needed for a comprehensive approach to care, from a gender perspective, despite the difficult conditions caused by the coercive measures imposed unilaterally by the Government of the United States against Cuba, and which have worsened during the pandemic. She also spoke of the process to establish a new family code, which included provisions relating to care.

29. The Minister of the People's Power for Women and Gender Equality of the Bolivarian Republic of Venezuela highlighted the approval of a national budget in which 76.4% of resources would be allocated to social investment in 2021, which included direct economic allocation to families. She referred to the Women Farmers plan and its progress in the allocation of land to Venezuelan women in order to effectively incorporate women into productive work through access to credit. She spoke about the reactivation of the 0800-Mujeres hotline to combat violence, and about the strengthening of the National Plan for Humanized Childbirth, in order to reduce maternal mortality. Finally, she reaffirmed her country's commitment to the eradication of violence against women and domestic violence, to the care economy, to social protection and to the creation of decent and productive jobs.

30. The representative of the Ministry of Women's Affairs of the Dominican Republic spoke about the incorporation in the National Gender Equality and Equity Plan of a line of action to design and implement a national care system based on a comprehensive, universal, rights-based and gender equality approach; a presidential decree formalizing the transformation of the poverty reduction strategy, including innovative care-related components in the framework of the *Supérate* programme; and the creation of an intersectoral committee on care. She also said that a pilot project had been planned in three priority territories, with the aim of developing care communities that would implement a new social organization of care in order to guarantee the right to be cared for and the right to provide care with dignity. She concluded by saying that budget protection lines had been established to ensure the implementation of the above-mentioned measures.

31. The Minister for Women's Affairs of Paraguay reported that the Ministry was leading the inter-agency steering group for the development of care policy in Paraguay (GIPC), whose tasks included the development of a road map based on a draft bill, the planning of a social debate and the formulation of the national care policy for subsequent formalization by the executive branch. She stressed the importance of promoting financial sustainability for the effective implementation of public care policies and concluded by announcing that Paraguay had already joined the Global Alliance for Care.

32. The Minister of Human Services and Social Security of Guyana said that her government had worked to regain pre-pandemic labour market trends and overcome the constraints faced in caregiving, and spoke about government efforts to carry out awareness-raising and co-responsibility campaigns. She highlighted the provision of cash transfers that have benefited women, such as the subsidy for public employees, which reduced the financial burden of childcare. She also mentioned the Women's Innovation and Investment Network, which included programmes that promoted financial independence and encouraged entrepreneurship, which had had an impact on reducing poverty and domestic violence.

33. The representative of Saint Lucia said that the new members of government had recently taken office. She recognized the need to develop gender policies in the context of the COVID-19 pandemic and to secure the necessary resources to implement them. She stressed that the Government of Saint Lucia had committed to guaranteeing those resources. Lastly, she called for collaboration between Caribbean and Latin American countries, with special attention to the tourism industry, a feminized sector that had been heavily affected by the pandemic.

34. The representative of UNDP spoke about the technical support activities of the inter-agency gender group composed of UNDP, UN-Women, ILO and ECLAC, whose aim was to assist countries with governance models and multisectoral and inter-agency responses, through institutional coordination committees including representatives of civil society and the private sector. She stressed the importance of synergistically addressing gender and socio-environmental inequalities and reiterated the commitment of UNDP to building a care society.

35. The Regional Coordinator of the Latin American and Caribbean Network of Trans Persons spoke about the worsening of violence, exclusion and discrimination against trans people. She stressed the importance of making diverse families visible and gave as an example the inclusion of trans people in the National Care System of Uruguay. Finally, she welcomed the good practices of some countries and stressed the importance of passing legislation to promote rights in that area, such as gender identity laws.

36. Finally, the Vice-Minister for Foreign Affairs of El Salvador highlighted some substantive advances that had been made in the country, such as the launch of the Women's Bank programme which promoted economic autonomy through lines of credit, the Women's Fund guaranteed loan programme

aimed at businesswomen and women entrepreneurs without collateral and the National Women's Entrepreneurship Programme. She also mentioned the passing of the Born with care Act for respectful childbirth and nurturing and sensitive care for newborns, and the Special Act on the regulation and installation of day-care for workers' children, aimed at promoting professional development and labour inclusion. In conclusion, she reiterated the government's commitment to guaranteeing women's rights, highlighting the right to a life free of violence and the right to inclusion in the labour market.

Report on the Regional Alliance for Women's Digitalization in Latin America and the Caribbean
(agenda item 3)

37. The report was presented by the Chair of the Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean, who said that the acceleration of digitization in the wake of the pandemic required measures to benefit women with no access to an Internet connection or who could not afford it. She stressed that there were multiple barriers to accessing technologies and economic opportunities, and that digitization was a key to access various financial services. In that regard, the Regional Alliance for Women's Digitalization in Latin America and the Caribbean was a collective, transformative and multisectoral commitment to promote inclusive transformation.

38. Since its launch in January 2021, two lines of action had been promoted: national programmes to help close the gender gap in access to new technologies with the support of ECLAC and the development of the collaborative virtual platform *Todas Conectadas*. The platform, which had been scheduled for launch at the end of October, aimed to reach a wide range of women and was composed of three spaces: a training space that offered courses for the development of digital skills, a space for meeting and creating communities to share networks and experiences, and a space for the creation of economic opportunities through job banks and inclusive banking. The platform was intended as a meeting place and collaboration with UN-Women to institutionalize the project was ongoing. In closing, she invited the participants to work together with ECLAC in the implementation of national programmes and to widely disseminate the Todas Conectadas platform.

39. In the ensuing discussion, the Minister on the Status of Women and Executive President of INAMU of Costa Rica recalled that her country had been part of the Regional Alliance since March, recognizing digitization as one of the five strategic themes of the INAMU agenda, and was willing to serve as the focal point for Central America, one of the subregions most affected by the gender digital divide.

40. The Minister for Women's Affairs of Paraguay said that her country was also part of the initiative to reduce the gender digital divide, which she hoped could bring new opportunities to women in Paraguay.

41. Lastly, the Deputy Regional Director for the Americas and the Caribbean of UN-Women stressed the importance of thinking in the medium term about a sustainability strategy, and of also involving national training institutes which, in most cases, had only recently incorporated the gender perspective into their training offerings at the national level. She expressed special thanks for the technical work that ECLAC had carried out to analyse the gender digital divide in each country and emphasized the potential of those tools to influence public policies.

Report on the Regional Fund in support of Women's and Feminist Organizations and Movements
(agenda item 4)

42. The Chair of the Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean said that the Regional Fund in support of Women's and Feminist Organizations and Movements was an innovative and multisectoral initiative and exemplified the spirit of cooperation needed to achieve transformative change. Given the consequences of the crisis, it was all the more important to recognize, support and strengthen feminist networks and organizations to counter the setbacks to women's

autonomy. She then spoke about the progress in the implementation of the Fund, including the participation of UN-Women as the Fund's administrative body and the announcements of the first financial contributions by the Government of Mexico and UN-Women. Progress had been made in defining the operational aspects, following the approval of a proposed operating manual for the management of funding, including objectives, governance, the roles of the board and the secretariat, mechanisms for receiving funds and the work schedule for the coming months.

43. She also said that the proposal for the first call for funding, focused on strengthening women's organizations and movements to promote women's autonomy in the face of the crisis, had been approved. It was due in the last quarter of 2021 and details were expected to be shared shortly. She clarified that the workplan included a call for applications, a communications campaign with a brochure, videos and a website, and the organization of resource mobilization activities to strengthen the Fund. Regarding the resource mobilization activities, she said that a donor round table would be organized in the second half of 2021, during the 16 Days of Activism against Gender-based Violence campaign. She also announced that the secretariat of the Fund had been established, which included Mexico as the first donor country, Chile as Chair of the Regional Conference on Women, three civil society organizations and UN-Women as the Fund's administrative body. Finally, she reiterated her call to the governments of Latin America and the Caribbean and of other regions, along with United Nations agencies, funds and programmes and other actors, to contribute financial resources to make the Fund sustainable, which would strengthen the role of civil society organizations in the realization of women's rights in the countries of the region.

44. Next, the representative of INMUJERES of Mexico, on behalf of the President of the Institute, reiterated Mexico's commitment to the Fund and recognized the importance of defining UN-Women as the Fund's administrative body to advance fund mobilization strategies. She welcomed the announcement of the donor round tables to be organized in the coming months, and the launch of the Fund's first call for funding. Mexico had taken administrative steps to implement the commitments announced in 2020 and the necessary procedures were being analysed to expand its contribution, which was expected to be finalized soon. Finally, she offered the support of INMUJERES to disseminate the call for funding so that it would have the widest possible reach.

45. Morena Herrera, representative of women's and feminist organizations and movements that are part of the secretariat of the Regional Fund in support of Women's and Feminist Organizations and Movements, said that the pandemic had confirmed the urgent need for the Fund and the importance of integrating women's and feminist organizations that were experiencing and knew about the worsening conditions of women in the territories. She thanked ECLAC and UN-Women for their technical support and spoke about the joint work with civil society to develop a logo, brochure and website. She was pleased with the first call for funding and preparation of donor round tables, and hoped that the initiative would help to energize the implementation and growth of the Regional Fund. The region was undergoing a difficult period characterized by democratic setbacks and, in spite of that, the organizations remained committed to continue fighting for women's rights.

46. In the ensuing discussion, the Chief of the Division for Gender Affairs of ECLAC shared the communication materials produced and noted that it was a key moment to fund the initiatives of feminist organizations and movements to support existing talent and recovery efforts.

47. Next, the Deputy Regional Director for the Americas and the Caribbean of UN-Women reiterated that the first call for funding would take place soon and clarified that any entity could become a donor to the Regional Fund, including countries in Latin America and the Caribbean. Finally, she expressed the hope that, despite fiscal constraints, countries could provide resources, such as those from unspent budgetary resources, and could include a possible grant in future budgets.

Discussion on the themes of the fifteenth session of the Regional Conference on Women in Latin America and the Caribbean (Argentina, 2022) (agenda item 5)

48. The Chief of the Division for Gender Affairs of ECLAC made a presentation entitled “The care society: a horizon for sustainable recovery with gender equality”, in which she underscored the urgency of the dual crisis: that generated by the pandemic and that of care. First, the pandemic had deepened the structural challenges of gender inequality and exposed the unfair social organization of care. ECLAC had therefore called for progress towards economic, climate and gender justice. Together with UN-Women and the Governments of Argentina and Chile, the Commission proposed the transition to a care society as the theme for the fifteenth session of the Regional Conference on Women in Latin America and the Caribbean. She explained that the goal of a care society was to prioritize the sustainability of life and the planet and to guarantee the rights of people in need of care and caregivers; a society that took into account self-care, that worked to reduce the precariousness of women’s lives and that raised awareness of the multiplier effects of the care economy on well-being and its ability to drive a transformative recovery with equality and sustainability.

49. She spoke about the importance of the Regional Gender Agenda in achieving women’s autonomy and gender equality, and of the feedback between the main global agenda (the 2030 Agenda for Sustainable Development) and that of Latin America and the Caribbean. The central role of care had been an increasingly important part of the Regional Agenda and the first time it had been explicitly mentioned was in the Regional Plan of Action (Havana, 1977). She also underscored the importance of quantifying and valuing the economic contribution of unpaid domestic work, the strengthening of the Statistical Conference of the Americas of ECLAC and the progress made by countries in the development of indicators. In addition, she highlighted the recognition of care as a right in the constitutions of Ecuador and the Plurinational State of Bolivia. The Regional Gender Agenda had progressively and coherently addressed the importance of incorporating universality, co-responsibility and financial sustainability into care policies, as well as global care chains, the links between care and well-being, the right to care, comprehensive care systems, countercyclical policies and, finally, care as a dynamic sector, key to a transformative recovery. She recalled that the implementation pillars of the Montevideo Strategy were the road map for building a care society.

50. The COVID-19 crisis was an opportunity to move towards a care society that prioritized care for the planet, health and people, along with self-care. She affirmed the need for a paradigm shift, to rethink production, consumption and distribution patterns, and to reorient finance towards the real economy, putting the sustainability of life at the centre. That involved linking care with the environmental agenda and the agenda for peace, which implied a number of methodological challenges. It was necessary to strengthen the role of States from a feminist perspective and to clearly define care policies and enabling policies, such as those relating to energy, transport and sexual and reproductive rights. In conclusion, she called for consensus-building ahead of the next Regional Conference on Women in order to achieve an equitable distribution of power, resources and time between women and men and to move towards a new development model.

51. In the ensuing discussion, the representative of Argentina said that the theme of the forthcoming Regional Conference was particularly important, as the burden of care work fell primarily on families and, within them, especially on women, girls and LGBTQI+ persons. Argentina had decided to place care at the centre of its policy agenda and, as a result, an interministerial round table on care policies had been established, bringing together 15 agencies of the national executive branch. In addition, *Programa Registradas* had been launched and, with the support of ECLAC, the federal map of care services, which made visible the supply of care services and training to promote the recovery of the domestic workers’ sector, one of the sectors most affected by the crisis.

52. The representative of Cuba said that a National Survey on Gender Equality had been conducted in her country, including a module on time use, which had contributed to the subsequent adoption of the National Programme for the Advancement of Women, by Presidential Decree No. 198. She also explained that a comprehensive strategy for the prevention of domestic gender-based violence had been adopted and referred to the new care provisions included in the draft of the new family code, which would be submitted for popular consultation and referendum in 2022.

53. The representative of Mexico said that the proposed theme for the next Conference was important and encouraging, given the historical moment in which it was taking place. The Global Alliance for Care could allow the region to learn about experiences elsewhere and continue to strengthen the multilateralism of the care agenda. She thanked Argentina for proposing the theme and ECLAC and UN-Women for the support and technical work carried out in relation to the concepts, costing and development of public care policies.

54. The representative of Nicaragua stressed that her country's legal framework recognized women's human rights and the distribution of care in both the Family Code and the Labour Code. She also listed the advances in establishing programmes promoting opportunities for rural women, women with disabilities and women of African descent, and ensuring prevention and attention to violence in all its forms.

55. The Director of Gender and Family Affairs of the Bahamas recommended that intersectionality and the vulnerability of women affected by disasters should be incorporated into the themes of the Conference. Furthermore, in terms of measurement and methodology, consideration should be given to the need for technical support to promote the production of comparable data. She outlined the challenge of formulating sustainable public policies in health that considered the rights of patients which were key to care—as the Bahamas was doing.

56. The representative of Brazil said that the Brazilian State had prioritized care following the establishment, in March 2021, of an interministerial committee for the creation of a national care policy, involving various ministries and consultations with different population groups and organizations involved in care. She expressed her thanks for the space offered by the Presiding Officers and the Regional Conference on Women in Latin America and the Caribbean to exchange experiences that allowed for the development of quality public policies.

57. The representative of Uruguay said that her country's National Care System was being overhauled and the main challenges lay in the plans to expand its coverage. Governments and international organizations needed to explore and develop two areas in order to ensure that citizens began to perceive care as a right and could demand the exercise of that right: on the one hand, communication aimed at bringing about a cultural change that would recognize care as a right and its economic value as a service, through campaigns, the education system and training; and, on the other hand, measurement, in order to make the economic value of care work in terms of GDP visible and to recognize its value not as an expense but as an investment.

58. The representative of Costa Rica agreed there was an urgent need to develop universal and progressive care systems and to establish care as a right and a public good, promoting the defamilialization of care and the recognition of care work as necessary. That entailed redistributing, revaluing and reformulating care, along with incorporating education models that would generate a cultural change and make care, shared responsibilities and the distribution of tasks in families more visible. She highlighted the need to advance the recognition of care work for the establishment of compensatory social security measures and called for a transition to a development agenda in which the conservation and restoration of nature was central, in order to ensure well-being for all people and to strengthen the resilience of women and girls in climate crises.

59. The representative of UN-Women said that her organization was supporting different countries in the region in the implementation of national and local care systems and that, together with ECLAC, they would soon be launching the document *Towards the construction of Comprehensive Care Systems in Latin America and the Caribbean: Elements for implementation*, which included experiences from the region and the world. She recalled that, at the next session of the Commission on the Status of Women, the intersection between climate change, gender and natural disaster risk reduction would be addressed, and the issue of care would also be discussed.

60. The representative of the Spanish Agency for International Development Cooperation (AECID) welcomed the long history of cooperation between AECID and ECLAC, which had contributed, inter alia, to the strengthening of the Regional Conference on Women in Latin America and the Caribbean and the Gender Equality Observatory for Latin America and the Caribbean.

61. The representative of FAO confirmed that the Organization was part of the Global Alliance for Care and highlighted the challenge of bringing key sectors, such as the private sector, into the Alliance. She also stressed the importance of women's employment in rural areas.

62. The representative of Colombia referred to the *Colombia se Reactiva con las Mujeres* strategy, which was based on four pillars: mitigating the economic effects of the pandemic, creating more employment opportunities, creating more opportunities for entrepreneurship and closing the digital divide. She also highlighted various initiatives, such as the Basic Income and Solidarity Income programmes, the creation of employment opportunities through differential subsidies, actions in the area of care —such as Law No. 2114, which created shared parental leave— and the promotion of entrepreneurship through the Fondo Mujer Emprende.

63. The representative of UNRISD highlighted the contribution of the research institute to the development of concepts associated with care, and the work it was doing on the costing of care services, along with the impact of the pandemic on the care crisis. He also mentioned an ongoing initiative to redefine the social contract, which involved analysing the gender contract underpinning inequality and incorporating the ecological dimension.

64. The representative of UNDP said that it was necessary to continue promoting care and incorporating it into the economic and social protection agendas, and to think of care not only in relation to some aspects of climate change, but as a central element of resilience to climate shocks and disaster risk. The concepts of intersectionality and interculturality encouraged thinking about care systems not only from an urban perspective, and understanding how indigenous women approached care. Finally, she called for the use of statistical systems, but also to look for new ways to use data creatively.

65. The representative of the Dominican Republic emphasized the challenge posed by the transition to a green and inclusive production model in line with the 2030 Agenda, which would only be possible through a collective global and multilateral effort. Work was under way to redirect the country's economy and, in coordination with various key actors, a national care committee had been created, an incipient process for which support and technical assistance were required.

66. Next, the representative of IOM recalled that migrant women should be given special consideration in care systems, as they often faced various barriers and forms of discrimination, and referred to the document "Recomendaciones para la elaboración de lineamientos para la atención y protección de las mujeres, niñas y personas sexo/genéricas diversas migrantes en América del Sur", which included the issue of care work.

67. The representative of Centro de la Mujer Peruana Flora Tristán expressed her support for the defence of a comprehensive, intersectional and intercultural approach in care policies. She said that a patriarchal society did not allow people to see the importance of care and self-care, and stressed the link between care and food sovereignty. She also highlighted physical autonomy and the fight against violence against girls, adolescent girls and women as fundamental.

68. The representative of Cotidiano Mujer reiterated the need to quantify and give an economic value to care. On behalf of Articulación Feminista Marcosur, she reaffirmed the importance of data as a basis for the formulation of care policies that promoted cultural change.

69. Next, the representative of Fundación para Estudio e Investigación de la Mujer (FEIM) and the Committee of NGOs on the Condition of Women from Latin America and the Caribbean welcomed the combination of the right to a better life and care for the planet, to which the Chief of the Division for Gender Affairs of ECLAC had referred in her presentation. She also mentioned the link between the government and the feminist movement in Argentina and was pleased to be able to welcome all participants to the forthcoming Conference.

70. The representative of Wellspring Philanthropic Fund stressed that “care society” was an innovative concept, an umbrella term that was grounded in the rights framework and sought to reposition women’s rights in the context of the challenges of the time.

71. The representative of UNICEF applauded the focus of the Conference and called for breaking gender norms in terms of role distribution from childhood. She said that co-responsibility strategies were essential and that the pandemic had shown that girls and adolescent girls also had caregiving roles, which had social, educational and economic implications. She argued that it was necessary for the Regional Conference on Women in Latin America and the Caribbean to address serious situations such as adolescent pregnancy and, in conclusion, proposed inviting young women and adolescent girls to the next Conference to work with governments and including their voices.

72. The representative of the Latin American and Caribbean Network of Trans Persons welcomed the meeting and said that trans women should be included in discussions about gender and in decision-making spaces. She reflected on the naming of ministries for women’s affairs, and the need to include the word “gender”, which included trans women and lesbian and bisexual women. Finally, she said that Argentina’s Gender Identity Act was a model for the whole region.

73. The Minister of Women’s Affairs and Gender Equity of Chile highlighted the passing in Chile of the Protected Parenting Act, the implementation of the Protege subsidy and the publication of the guide “Paso a paso: corresponsabilidad en los hogares” on co-responsibility in households. She also spoke of a bill to expand the right of access to children’s day-care centres and highlighted the work done with the Ministry of Social Development to create the *Chile Cuida* system of support and care for dependent persons.

Preparations for the fifteenth session of the Regional Conference on Women in Latin America and the Caribbean (agenda item 6)

74. The Chief of the Division for Gender Affairs of ECLAC presented the road map towards the fifteenth session of the Regional Conference on Women in Latin America and the Caribbean, which would take place in 2022 in Argentina. She said that the sixty-second meeting of the Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean was being planned for end-January or early-February 2022. The idea was to hold the fifteenth session of the Regional Conference in-person in

Argentina, and it would be convened in the last quarter of 2022, at a date and venue to be determined. At the sixty-second meeting of the Presiding Officers, as in previous meetings, a consultation would be conducted in preparation for the sixty-sixth session of the Commission on the Status of Women, to be held in March 2022. Focus would be given to climate change and environmental policy, to which end a document and declaration by national machineries for the advancement of women would be drafted for consideration by the Presiding Officers. Once approved, they would be submitted to the global meeting in March.

75. ECLAC would prepare a presentation on a preliminary draft of the annotated index of the position paper for the forthcoming Regional Conference, which would be distributed to the participants in the meeting. Prior to that, in November 2021, ECLAC and UN-Women would publish a preparatory document on care systems and organize a meeting of specialists to provide additional inputs for reflection. She specified that subregional sessions would be organized for discussions on the elements of the position document for the Conference. In the run-up to the Conference, the Forum of Latin American and Caribbean Feminist Organizations would be held, and it was hoped that women, young women and adolescents, as well as a diversity of women, would participate. She said that, as in previous meetings, governments were kindly asked to ensure that their delegations included a wide range of stakeholders. She confirmed that countries would be given guidance for the preparation of their voluntary reports, which should inform on the follow-up to the commitments undertaken in the Montevideo Strategy and the Santiago Commitment. She concluded by expressing her hope that the Conference would culminate in a landmark agreement that would contribute substantively to the Regional Gender Agenda.

76. The Regional Director for the Americas and the Caribbean of UN-Women reaffirmed the central role of care in advancing towards more egalitarian societies and expressed her hope that the outcome of the fifteenth session of the Regional Conference would help to solidify the region's global leadership through the Global Alliance for Care. She stressed the need to link care with environmental sustainability, as well as the importance of adopting a clear regional position before the next session of the Commission on the Status of Women. Recalling also that the Seventh Regional Platform for Disaster Risk Reduction in the Americas and the Caribbean would be held in 2021, organized by Jamaica, she said it was an opportunity to review the progress made in mainstreaming gender equality in that area. Lastly, she stressed that there could be no effective response to the crisis if women in all their diversity were not included.

77. The Minister of Women's Affairs and Gender Equity of Chile, in her capacity as Chair of the Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean, shared her hope that the upcoming Conference would be collaborative and innovative space that would give governments a strong push to advance gender equality, injecting the necessary resources and cooperation efforts to make a qualitative and quantitative leap in the implementation of care systems in the region. She said that, at the next session of the Commission on the Status of Women, an effort would be made to translate the region's proposal into a global agreement. She underlined that Chile had worked actively to include the gender perspective in the climate change agenda and reiterated her country's commitment to amplifying the voices of women who struggled daily against the climate crisis, giving special attention to Caribbean women, indigenous women and women environmental defenders.

78. Next, the Minister for Women, Gender and Diversity of Argentina, in her capacity as Vice-Chair of the Presiding Officers and representative of the host country of the fifteenth session of the Regional Conference on Women in Latin America and the Caribbean, said that the Conference was a unique forum for sharing the advances and challenges relating to the Regional Gender Agenda and stated that one of its main objectives was to provide a participatory and multisectoral space where everyone, in particular feminist movements, had a voice. She hoped that the fifteenth session of the Conference would be held in-person and that the epidemiological situation would be such that participants could attend, with all necessary preventive measures in place. Noting that it was essential to strengthen the political agenda and the

international legal framework for human rights, she referred to the MERCOSUR recommendation, presented by Argentina, which called for the construction of comprehensive care systems, as well as the International statement about the importance of care in the human rights arena, which had been co-sponsored by Argentina and Mexico and adopted at the forty-eighth session of the Human Rights Council of the United Nations.

Other matters (agenda item 7)

79. Under this agenda item, the Vice-Minister for the Protection of Women's Rights of Paraguay proposed the establishment of a round table on rural women and their financial and digital inclusion. She noted the many disadvantages faced by rural women in terms of access to education, reproductive health, financing, land and leadership positions, and said that a cross-cutting strategy was needed to close those gaps. Given the current digital context, technological tools and connectivity were key for driving sustainable development in the region. She mentioned the Law on public policies for women in rural areas, in force in Paraguay since 2015, which provided for the creation of specific programmes to facilitate women's access to land, as well as the implementation of differentiated business development strategies, and the Agrarian Statute of 2002, which recognized the need to promote women's access to land ownership, ensuring that they could put down roots through access to ownership titles, credit and timely technical support. She also recognized the importance of having up-to-date public data on rural women's access to land, noting that the gender perspective was yet to be incorporated in land reform.

80. The Minister on the Status of Women and Executive President of INAMU of Costa Rica thanked ECLAC for raising the issues of climate justice, which was of particular interest to her country given its commitment in that area and its ongoing mitigation efforts in line with the decarbonization plan, and women's participation in new ecosystems in the framework of the transition towards green energies.

81. The representative of the University Network of Young Entrepreneurs in the Plurinational State of Bolivia highlighted the importance of strengthening the forums for dialogue on unemployment, particularly among young women, and technological and social entrepreneurship, which helped to raise awareness of initiatives in this field.

Consideration and adoption of agreements (agenda item 8)

82. The representatives adopted the agreements contained in annex 1 of this report.

Closing session

83. In the closing session, the Chief of the Division for Gender Affairs of ECLAC underscored that the Presiding Officers provided a necessary space for political dialogue and cooperation for regional integration towards a transformative recovery, with gender equality and sustainability at the centre. She thanked the participants for the rewarding work over the last two days, which had culminated in a set of agreements aimed at providing continuity to the work on multiple fronts, as well as moving forward with the implementation of the Regional Gender Agenda and the organization of the next Regional Conference on Women in Latin America and the Caribbean. She also emphasized the need to work together to build a care society, which called for a paradigm shift and a new development model. She stated that ECLAC aimed not only to draw attention to care as a sector of employment, primarily made up of women, but also to ensure that care was recognized as a public good —essential for life— that could not be resolved only within the family and the home, but should rather be addressed in terms of co-responsibility. She concluded

by underlining the key role of ministries and national machineries for the advancement of women in mainstreaming gender in all crisis response measures and implementing affirmative action for a transformative recovery with gender equality.

84. In her closing remarks, the Regional Director for the Americas and the Caribbean of UN-Women stressed that it was important to remember that women were diverse and faced different challenges, especially so for rural, indigenous, Afro-descendant and young women. She therefore urged participants to devote more attention to the region's young women, who were the future. She also recalled that the Regional Conference on Women in Latin America and the Caribbean was the only such instance in the world, and that strengthened the regional position in international forums such as the Commission on the Status of Women, the General Assembly and the high-level political forum on sustainable development.

85. The Minister of Women's Affairs and Gender Equity of Chile, in her capacity as Chair of the Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean, appreciated the outcome of the two days of work and noted that the theme of the forthcoming Regional Conference was an opportunity to move towards a care society with a feminist and human rights approach. She called for concrete public and monetary policy actions, in preparation for the Conference, to shape economic recovery strategies that encompassed the care economy as a key sector in order to move towards an inclusive society that guaranteed the rights of women in all their diversity. There were valuable lessons to be learned from the crisis, which provided an opportunity to build more resilient, sustainable and equitable societies, leaving no women behind and prioritizing those in need of special protection, such as indigenous women, rural women, women with disabilities, the LGBTQ+ community, migrant and displaced women, and women human rights defenders and climate justice advocates. In closing, she reaffirmed that gender equality was a rights issue and had a multiplier effect for the good of society as a whole, leading to inclusive growth, more and better democracy, sustainable development and a peaceful society.

Annex 1

AGREEMENTS

At their sixty-first meeting, the Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean agreed to:

1. *Reaffirm* the importance and urgency of implementing the agreements adopted at the sixtieth meeting of the Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean and reiterate that the coronavirus disease (COVID-19) pandemic has had unprecedented effects on sustainable development in its three dimensions —economic, social and environmental—, leading to the sharpest contraction of economic activity in the region’s history, with a disproportionately heavy impact on women and girls that deepens the structural obstacles of gender inequality;
2. *Reiterate* their call for COVID-19 response and recovery policies to incorporate a gender perspective, to include participation by all women and girls in their design and implementation and to help to overcome the multiple and intersecting forms of violence, discrimination, exclusion and inequality that disproportionately affect women and girls in all their diversity and are manifest in increased unemployment and poverty, as well as in the overburden of paid and unpaid domestic and care work, and which threaten to widen existing gaps and reverse progress towards the achievement of the Sustainable Development Goals and the Regional Gender Agenda;
3. *Reaffirm* the commitment to take all necessary measures to accelerate the effective implementation of the Beijing Declaration and Platform for Action and the Regional Gender Agenda, strengthening gender equality institutions and architecture through the prioritization of machineries for the advancement of women and gender mainstreaming at the different levels of the State, by increasing the allocation of financial, technical and human resources, gender budgeting, and monitoring and accountability, with citizen participation, which will foster public policies for response to the COVID-19 pandemic and a transformative and gender-equal post-pandemic recovery;
4. *Reject* unilateral coercive measures, which are a violation of human rights, including the right to development, generate social inequalities with disproportionate impacts on the lives of women and girls that are worsened in times of pandemic, and hinder the effective implementation of the Beijing Declaration and Platform for Action, as well as the 2030 Agenda for Sustainable Development and the Sustainable Development Goals;
5. *Thank* the representatives and participants in the high-level panel “Towards a care society for recovery with gender equality and sustainability”, and acknowledge the value of that panel as a regional space for discussion and reflection regarding the deepening care crisis in the context of social and economic effects of the COVID-19 pandemic, which is having a disproportionately high impact on women and girls by intensifying the structural obstacles to gender equality, and for the preparation of proposals for fifteenth session of the Regional Conference on Women in Latin America and the Caribbean;
6. *Welcome* the report on the Regional Alliance for Women’s Digitalization in Latin America and the Caribbean;

7. *Also welcome* the report on the Regional Fund in support of Women's and Feminist Organizations and Movements, presented by its Board of Directors, which refers to the first call to strengthen women's and feminist organizations and to progress made regarding operational aspects of the Fund;

8. *Encourage* the governments of Latin America and the Caribbean and of other regions, developed countries, the agencies, funds and programmes of the United Nations and other relevant stakeholders to contribute financial resources to ensure the sustainability of the Regional Fund in Support of Women's and Feminists Organizations and Movements;

9. *Commend* the Generation Equality Forum, convened by the United Nations Entity for Gender Equality and the Empowerment of Women and co-hosted by Mexico and France, first in Mexico City from 29–31 March 2021 then in Paris from 30 June to 2 July, along with the active and committed participation of the countries of the region in this process, and notably of members of civil society and feminists in the region, especially from youth organizations;

10. *Welcome* the International statement about the importance of care in the human rights arena, presented jointly by Argentina and Mexico and co-sponsored by 50 countries at the forty-eighth session of the Human Rights Council of the United Nations, on 22 September 2021, which underscores the importance of care as a human rights issue, recognizes the importance of care for countries' development and the need to foster greater redistribution of care, and calls for the elimination of legal, institutional and policy barriers for the benefit of the human rights of women and girls, particularly to guarantee their full and effective participation in the economic sphere;

11. *Welcome* the Global Alliance for Care Work, launched by Mexico with the support of the United Nations Entity for Gender Equality and the Empowerment of Women, as a co-creative space for multiple actors where governments, international institutions, the private sector, the academic sector, philanthropic organizations, young people and civil society organizations can share experiences and good practices to make progress in the agenda for the right to care at the global level, recognizing the support expressed by some countries of the region for this agenda and inviting the other countries of the region to join this initiative;

12. *Commend* the progress made by some countries of the region with regard to ensuring that all women and girls exercise their sexual and reproductive rights free from violence and discrimination;

13. *Request* the Economic Commission for Latin America and the Caribbean and the United Nations Entity for Gender Equality and the Empowerment of Women to jointly organize the Latin American and Caribbean regional consultation in preparation for the sixty-sixth session of the Commission on the Status of Women, in the framework of the sixty-second meeting of the Presiding Officers of the Conference;

14. *Adopt* the subject “The care society: a horizon for sustainable recovery with gender equality”, as the central theme of discussion at the fifteenth session of the Regional Conference on Women in Latin America and the Caribbean, taking into account the contributions made at the present meeting;

15. *Also adopt* the proposal of the secretariat on the road map for the preparatory process of the fifteenth session of the Regional Conference on Women in Latin America and the Caribbean, which includes subregional sessions, meetings with experts and a broad participatory process, and urge the governments to participate activities in the activities to be carried out in the first half of 2022;

16. *Commend* the Government of Chile, in its capacity as Chair of the Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean, for the fruitful organization of this meeting of the Presiding Officers;

17. *Acknowledge* the Government of Argentina, in its capacity as Vice Chair of the Presiding Officers, and express thanks for its report, as host country, on the preparations under way for the fifteenth session of the Regional Conference on Women in Latin America and the Caribbean;

18. *Advance* recovery plans with affirmative actions that foster comprehensive care systems, decent work and the full and effective participation of women in strategic sectors of the economy for a transformative recovery with gender equality aimed at the sustainability of life and for the transition to a care society.
