


An assessment tool created by United Nations Statistics Division

Assesses country's current position in environmental data collection

Administered to relevant government ministries






In particular the ESSAT:


Guides data collection and compilation at a national level

Overall sets a basis for strengthening the environment statistics programs within the NSS.

Assesses: national relevance, importance, availability and the sources of environment statistics.

Assists in identifying data gaps and overlaps





Framework for the Development of Environment Statistics (FDES)


Hierarchical structure of the FDES in descending order






Total number of statistics <u>458</u>

There are three types of statistics (TIERS)

TIER 1: Minimum set that each country should produce

TIER 2: Good medium term statistics

TIER 3: Difficult to produce in short and medium term



TIER 1 statistics:

Basic minimum set of environment statistics

Recommended for production in the short term

They are of high priority and relevance

Have a sound methodological foundation.







TIER 2 statistics:

Highly encouraged to have if the situations apply

They require a greater investment in Time Resources Methodological development

Countries are encouraged to produce them in the medium term.






TIER 3 statistics:

Require a more significant investment in Time Resources or Technological development.

Recommended for production in the long-term.



The Statistical Institute of Belize lead the completion of the ESSAT, in partnership with the Department of the Environment (DOE).

19 Agencies were sent relevant sections of the ESSAT Part II, of which 17 participated (90%).

One-on-one consultation sessions were conducted with all participating agencies.

An assessment of all indicators in the ESSAT Part II was done to remove indicators not relevant to Belize.


Availability of Information for Data Assessment Gap





Proportion of Available Statistics Belize




Identical vs Similar Available Statistics
