New 10-year SIDS Agenda adopted


### Monitoring Progress of the SAMOA Pathway

- SAMOA Pathway did not establish indicators for monitoring, tracking/assessment and reporting implementation
- Other Sustainable Development Frameworks developed after the SAMOA Pathway and which have existing Monitoring and reporting Frameworks
  - 2030 Agenda on Sustainable Development and its 17 SDGs.
  - Sendai Framework on Disaster Risk Reduction
  - Addis Ababa Action Agenda on Financing for Development
  - Paris Agreement on Climate Change
- Proposed SAMOA Pathway Monitoring and Evaluation Framework
  - 63 policies, programmes, and project development priority actions requiring qualitative assessment
  - 76 priority actions aligned with SDGs and the Sendai Framework requiring <u>quantitative assessment</u>
- UNGA Resolution 76/203, paragraph 22
  - Welcomed the development of a monitoring framework for the SAMOA Pathway
  - Encouraged SIDS to utilize a framework for reporting ahead of the Fourth International SIDS Conference

In 2022- the SDG reporting framework was used to report in the progress of the SAMOA Pathway. This approach provided for tracking and measuring of progress- where data is available

Caribbean SIDS made appreciable progress with some areas but regressed in others - selected examples are:

Progress made in expanding access to broadband internet and increasing renewable energy generation

Progress in controlling tuberculosis and reducing neonatal, maternal, infant and under 5 mortality

Regression in conservation of natural habitats and in the prevention of violence with more than 50% of countries reporting increases in intentional homicide between 2014 and 2019

Almost three quarters of Caribbean SIDS recorded a decline in their share of global exports between 2014 -2019

### Towards the Fourth International SIDS Conference – SIDS Priorities

- New SIDS Agenda should be supported by a:
  - Results based Framework
  - Monitoring and Reporting Mechanism
  - Financing and partnership strategy

Aligned with new and existing sustainable development agendas



Post SAMOA Pathway (2014) Global Sustainable Developmental Agendas

The SAMOA Pathway is congruent with other global sustainable development agendas such as:

- 2030 Agenda on Sustainable Development (2015),
- The Sendai Framework for Disaster Risk Reduction (2015),
- The Addis Ababa Action Agenda(2015),
- . The Paris Agreement (2015) and
- New Urban Agenda (2015).

The Mid-term Review of the SAMOA Pathway (2019) — recognised these Agendas in strengthening and supporting the SIDS priorities for sustainable development.



## Towards the Fourth International SIDS Conference – Key Priorities for SIDS

- Financing has been identified as a key area for prioritization
  - Access to affordable financing
  - Debt repayment
  - Debt sustainability
- Multidimensional Vulnerability Index
- Resilience building
  - Impacts of climate change and other natural disasters
  - Increased investments in building resilience
  - Climate financing







#### Towards the Fourth International SIDS Conference – Other SIDS Priorities

Considered SIDS Priorities for Next 10years (2024-2034) and

identified during the Wadali Action Platform (August 2022, Antigua and Barbuda):

- ✓ Sustainable livelihoods
- ✓ Innovative centers that allow the SIDS population to be at the forefront and earn maximum value added in the future
- ✓ Environment including- Marine Plastic pollution
- ✓ Connectivity (goods, services, people, digital, cultural)
- ✓ Overcoming the digital divide
- ✓ Collection of adequate data to track implementation results
- ✓ Data availability and strengthening national and regional statistical systems
  - ✓ Access, assess and support data driven decision making
