


# Caribbean Situation ICP 2021 (Foods and Beverages Year 2019)

  - There are 175 Items, 11 of which are regional list.













#### Total records by basic headings - Year 2019 (n = 10)



#### Total records by basic headings and countries - Year 2019 (n = 10)








