

Participation of the Public

- ✓ Representatives in the Presiding Officers
 - ✓ Right to submit proposals
 - ✓ Open meetings
 - ✓ Timely information and outreach by appropriate means

Proposals/Inputs:

Include community radios, free TV channels and podcast



Regional Public Mechanism (RPM)

- ✓ To continue RPM
- ✓ ECLAC continues managing the RPM
- ✓ The COP and subsidiary bodies must be proactive in sending information to the RPM
- ✓ All notifications and draft should be sent to the RPM.

Proposals/inputs:

- ECLAC has done a great job.
- Pro tempore Presidency to work with ECLAC in the RPM
- Bodies have the duty/the obligation to inform the RPM.
- Reasonable deadlines.



Representatives of the Public

- ✓ New election
- ✓ Representatives to develop Terms of Reference
 - ✓ Secretariat to support election

Proposal/inputs:

- Public has the opportunity to assess Representatives.
- Candidates: Vulnerable groups, indigenuos communities, legal experts, private sector, and local communities.
- Gradual change of Representatives so we don't lose experience.
- Include in TOR the preparation of guidelines on good practices.
- ECLAC can count with a Neutrality Commission.



A Clarification on a legally binding participation

- The participation of the public and the Representatives have had the objective to advocate with our proposals and influence the governments decision making process.
 - This is not a legally binding participation. Final decisions are up to governments.
